Essential Functions	<ul style="list-style-type: none"> • Provide one-on-one or group tutoring services as required • Keep regular and accurate records of tutoring sessions using appropriate forms • Maintain confidentiality of office/student information • Attend tutor training sessions as required • Foster a customer service environment for fellow employees, students, and visitors. Be an Ambassador for the College. Support the college’s initiative to maximize retention of current students and enable students to finish their collegiate goals. • Comply with all policies of the Alabama Community College System Board of Trustees, the ACCS Chancellor’s Office, and the College. • Participate in College functions (Award and Honor events, Alumni Homecoming, Commencement, Parson Days, etc.) • Assume other work related responsibilities as assigned by the appropriately assigned College administrator.
