



Dear Prospective Student,

Thank you for your interest in the Nursing Program at Snead State Community College. Enclosed you will find the information necessary to apply for admission into our program.

Students meeting minimum admission standards may apply for admission to the Associate Degree Nursing program. To be considered for admission, a completed application packet must be received either by mail or hand delivery to the Department of Health Sciences by 4:00 p.m. on May 15, 2020. Applications sent by mail must be postmarked by May 15th. **No application packets will be accepted after the deadline.**

A completed application packet consists of

- Nursing Program application
- Transcripts for **all** prior college work attempted
 - i.e., if you have attended a total of 3 colleges, you must submit all three transcripts
 - Unofficial copies will be accepted for nursing application purposes
 - Due to student confidentiality guidelines, the Nursing Dept **will not** request transcripts from the Office of Student Services. **Therefore, only transcripts attached to your application will be evaluated for admission.**
 - *SSCC students can print Snead transcript online through MySnead account
- High School transcripts (required only for students with no previous college work)
- A copy of ACT composite score of 18 or higher (No expiration on ACT scores for nursing application purposes)

FAILURE TO FOLLOW THESE INSTRUCTIONS WILL RESULT IN AN INCOMPLETE PACKET, WHICH WILL NOT BE EVALUATED.

Pre-Application Seminars for the SSCC Nursing Program will be offered during the Spring Semester for applicants planning to apply for Fall admission. Applicants are encouraged to attend one of the sessions for valuable information about the nursing program prior to submitting the nursing program application. Applicants will receive 2 application points for attending one of our seminars & attaching the original attendance certificate to their application.

MINIMUM ADMISSION STANDARDS INCLUDE

- Admission to Snead State Community College
- Good standing with Snead State Community College
- Receipt of completed application packet by 4:00pm – May 15th
- A minimum GPA of 2.50 (calculated based on grades earned in Pre-Nursing General Education courses)
- A minimum of 2.50 cumulative high school GPA for students without prior college work (GED acceptable)
- Eligibility for ENG 101 and MTH 100 (College Algebra) as determined by College policy
- Ability to meet essential functions/technical standards required for nursing
- ACT composite score of 18 or higher

Meeting minimum requirements does not guarantee acceptance into the program. Qualified applicants will be rank-ordered and only a predetermined number will be selected.

I understand that completion of this application is a component of the student profile and does not in itself grant admission to the nursing program. I certify that the information given in this application is true and correct. I understand that providing false information may be deemed sufficient reason to dismiss the student and/or refuse admission.
